# Treasurer's Report

The Treasurer's Report was circulated prior to the meeting.

Malcolm spoke to his report.

The 2023 accounts have been prepared and reviewed by Helen Reeves.

Our balance of funds as of 31 December 2023 was \$18,560.07.

The Association had a net loss for the financial year of -\$15,352.88, compared to a closing balance of \$33,912.94 and a net loss of -\$12,290.39 for the previous year.

The large decrease in funds is due to the losses from Junior and Senior nationals.

The Association Bank balance as of the 1st May 2024 sits at \$15,343.37 less TES makes it \$9943.37.

There were no new assets purchased during the reporting period and all existing assets have no book value so there was no depreciation.

Our statement of financial position liabilities (\$2743) are payments made in the 2024 year for activity in the 2023 year. E.g. additional senior nationals related expenses.

Due to our current bank balance and status, we are looking at increasing both senior and junior membership levies and national ticket levies. With a declining bank balance, the Exec are working

and finding ways of trying to save money with all our events like the AGM, Judges workshops and combining our National events.

# SENIOR AND JUNIOR NATIONAL REPORTS

# Senior Nationals 2023 Report - City of Sails

Circulated prior to this meeting

#### Linda spoke on behalf of City of Sails, in summary:

The venue was very good, apart from some dance floor issues that were resolved and kept acceptable throughout the weekend. The sub-committee was made up of 6 club members and this was a good small number to get things done. During the weekend we had around 20 helpers on a roster to cover the logistics of running the event and looking after the venue.

The Auckland Netball Centre had plenty of space so we gave the casual public sales of morning and afternoon sessions, full access to the dance floor and seating with their club if they wanted. This worked well and we sold just over 300 public tickets over the whole weekend, providing \$6,160 in revenue. Tiered seating was well utilised across the weekend giving great views of the dance floor.

We would like to thank Duncan and Nigel for the music and Daniel Zainey for being MC. Of course the NZARRA Executive deserve a round of applause for their work in organising the weekend programme and the Officials who worked tirelessly to judge, administer, etc. without which, we could not have a competition. Thank you to everyone who worked in an official capacity.

The officials were provided a van loaned by a club member and driver, also a club member. We were lucky to have one of our committee look after the catering for the officials throughout the weekend and we were loaned a water cooler for the judges table area.

As with all previous hosting, we made a big effort in applying for grants. This was very important as we were never sure of the profitability of the event. One of our members put in a lot of effort securing grants worth over \$6,000 from three charities, namely; Pub Charity, Four Winds Foundation and the NZCT Community Trust. A bit of advice for the future, get your grant submissions in nice and early prior to paying the bulk expenses, as you do not normally get grants for costs that you have already paid. We were successful with costs towards first aid, equipment and venue hire.

The venue accepted motorhomes and this was very popular. We had 20 registered motorhomes and all had to have a current self-containment certificate and prepaid a \$25.00 registration fee.

The financials were provided and show a profit of \$23,759.66. This was despite a lower-than-expected attendance number. We had close to 300 prepaid actual attendees including competitors. We had early bird ticket pricing of \$90.00 for the full weekend and kept this price throughout due to our success with grants. Keeping costs to a minimum i.e. self-catering for officials, running raffles and successful grants, made the overall event more profitable for the club than budgeted.

# Junior Nationals 2024 Report - Invercargill

We would firstly like to thank everyone who travelled to Invercargill and supported Junior Nationals 2024.

What a weekend! We set out to have fun-filled Nationals and wanted to create an atmosphere that was exciting for all - we hope that all competitors, supporters and officials had a great experience. Although competitor numbers were low we filled the room and hope that those clubs who did attend will spread the word about what a great national event RnR has every year and will hopefully encourage growth of our junior numbers across all clubs for the future.

To date we have made a profit of \$6566.00. Included in this we did have merchandise available for sale however this did not return much profit so we wouldn't advise doing this for future junior nationals. We have 8 non-competitor badges left that will be available at the AGM for \$10 each.

We sold 137 weekend floor passes, 20 Friday floor passes, 19 Saturday floor passes, 8 Sunday floor passes, and 186 grandstand tickets for the weekend.

8 DVDs and 8 flash drives were ordered.

Social media engagement with other clubs was limited until we approached each club individually and after that was very successful, perhaps contact each club earlier in the future for social media purposes.

Thank you for the opportunity to host Junior Nationals 2024, we had so much fun working together on this and wish the Kapi Mana team all the best with Junior Nationals 2025.

#### **Senior Nationals 2024 Progress Report - Christchurch**

Circulated prior to this meeting.

Christchurch club is ready to welcome all clubs to the 2024 Senior Nationals.

We want to acknowledge that it is 40 years since the first Senior National Championship hosted by Coasters Rock'n'Roll Club in Gisborne. However, because of Covid19 interruptions, this in fact will be the 38<sup>th</sup> Senior Nationals.

We have hired Lincoln Event Centre, 15 Meijer Drive, Lincoln. This is a proven venue, just 15 -20 minutes from the city, with a really good dance floor and warm up area. There is ample car parking and a water refill station. Table seating will be limited, depending on numbers. Every club will have some table seating and there is plenty of wooden tiered seating. We do recommend bringing stadium cushions.

The centre is a council owned facility and therefore we are restricted in some areas, for example, we are unable to hang banners around the walls. We are making provision for the Association Banner, which will be as usual behind the stage. Clubs can bring pull up banners to display.

Accommodation in Lincoln & Rolleston is limited, we recommend any club still seeking accommodation to look at providers in Riccarton, Blenheim or Lincoln Roads, all have a number of motels, and are within 15 minutes easy drive of the venue.

While motorhome parking is not permitted in the stadium car park, we have arranged parking with the nearby Lincoln Primary school, just 5 minutes' walk away. Anyone wanting to use this parking can contact Karyn Thomson kethomson@xtra.co.nz . The school is not charging for this use, but we would appreciate users making a small donation which we can pass on to the school.

We are currently applying for an alcohol licence, and are hopeful this will be granted. This will be for the purchase of alcohol evenings only. There will be no BYO at all. As we will be providing the drink and bar staff, the cost will be competitive.

For venue tickets we will be using "ITicket". This is a reliable New Zealand company, and they have offered very generous terms as far as fees go, especially with bulk purchases, where the fee will be capped. We will have details soon with pricing and links to the provider. There will be an "early bird" price to encourage clubs to be prompt with their purchases. The ticket price is subject to the outcome of Remit 2.

The plan for Friday evening is to have local market stalls, and a casual meet and greet evening with DJ music. "Let's Jive" will be on site all weekend, as will our seamstress team for any running repairs.

Our DJ's are Duncan & Nigel, and we have Rotorockers video team for their last hurrah.

We are working on getting coffee carts and food options at the venue. Lincoln Township is well served with cafes, takeaways, pubs, restaurants and a very good supermarket.

Our theme is Legends of Rock'n'Roll, and while this of course is all those artists who created our music, fashion etc. it is also all our local dancing legends, the 3 times winners from over the years. We also note that in the 40 years since that first event, there have been just 12 presidents, 20 Vice Presidents, 11 Secretaries, 15 Treasurers and 12 Head Judges. Some of these people have been in more than one role within the organisation over that time. #### **VENUE:**

Te Rauparaha Arena, Porirua

- Kapi Mana has pencilled in bookings for the main and small stadiums at Te Rauparaha Arena.
   A decision as to which stadium will be used is subject to the outcome of matters to be raised at the NZARNRA AGM, the report on the 2024 Junior Nationals, and indications of likely support for/competitor numbers at the 2025 Juniors.
- Contract time is 3pm Friday 18 April to 12pm Sunday 20 April.
- Contract includes a stage, hire of meetings rooms, chairs, and 30 tables.
- Per the 2016 and 2021 Junior Nationals hosted by Kapi Mana at Te Rauparaha Arena, should the event be held in the main stadium then two thirds will be used for the dance floor/seating /stage with one third screened off for a warm-up/practice area.
- If the event is held in the small stadium arrangements are in hand to screen off a section for a warm-up/practice area.
- Kapi Mana has also explored the option of using an alternative venue in the event the anticipated number of competitors is lower than expected.

# <u>Proposed Constitution Change 1 - Executive</u>

Amend Section 18 (a) to add 'or a Special General Meeting of the Association'....

#### To read:

"The Constitution may be altered only if a motion of the proposed alteration is sent in writing to the Secretary at the registered office of the Association at least 90 days prior to either the Annual General Meeting or a Special General Meeting of the Association, and has been put at that meeting and carried by two thirds majority of the total of Member Clubs and Executive Committee present and entitled to vote".

#### Reasoning:

The current Constitution states that any changes can only be made at an AGM. In order to ratify the new Constitution required by Incorporated Societies, allowing this to be done at a Special General Meeting would then allow changes to be presented prior to a yearly AGM.

# **Proposed Constitution Change 2 - Harbour City**

Seconded by L&P

#### Add new clause under current Constitution Rule 9b:

"General Meetings will be held at one or more venues using any real-time audio, audio and visual, electronic or in-person communication that gives each member a reasonable opportunity to participate."

# Reasoning:

We propose this change so that all AGM's and SGM's are run on-line, or at the discretion of the Association, a combination of on-line and in person.

For a long time there has been relatively low attendance at the AGM, which is a key meeting for us as an incorporated society, and we have heard that the related costs, plus time required for travel, are barriers to clubs attending.

Meeting and conversing online is now a common and familiar activity for most, particularly post our COVID lockdown.

It is important that we encourage as many clubs as possible to take part in the business of an AGM, including understanding the financial position of the Association and electing its officers, and remove barriers to doing so. We feel it would encourage more people to attend if the time required to attend a meeting was shorter (did not incur travel time) and at no or low cost to attend.

Although we agree with comments previously made when this was suggested - that meeting in person is good, more social, and encourages more side-conversations, etc - that is secondary to an AGM's main purpose. This change also supports that preference, if there is continued appetite by some for a physical meeting.

#### Harbour City spoke to their Constitution change reading out the reasoning above.

16 clubs here today which is great but 10 clubs are missing. Clubs may be reluctant - due to the cost to attend or have to leave a day earlier - have to consider accommodation costs.

We had to have the AGM online during covid and we managed but was not the first choice but we do now have more ways to run AGM's. This would also help financially.

zoom - seems lazy.

City of Sails For - Zoom or in person. Prefer not combined. Does this hall allow wifi

easier.

Christchurch Give the choice by zoom, or combination or physical. Give as much

flexiabilty to the Executive when the time comes.

Cambridge Discussions are valuable - we prefer one or the other option.

Secretary One or the other - not together, makes it harder to run the meeting

having to worry about those online as well as those in the room.

Surf City Zoom meetings - find it harder - don't feel comfortable on zoom.

Prefer in person.

City of Sails Do we need to put in an amendment?

Dunedin Spend alot of time on zoom - consider every other year in person - get

a much better meeting when face to face. Believe it's not worth the

expense of what we will lose if we go totally online.

Harbour City Right of Reply Discretion is up to the Executive about how they would host it.

We might not have a meeting in wellington. Can be anywhere.

We wouldn't expect wifi.

Managing both would be interesting.

# **Proposed Constitution Change 3 - Harbour City**

Seconded by L&P Rockers

**Amend first sentence of section 13** to **remove** "to be elected at the Annual General Meeting by the members, the"

Add a new second paragraph to Section 13.

#### To read:

"The President, Vice President, Secretary and Treasurer are to be elected or appointed at the Annual General Meeting by the members present."

# Reasoning:

Current wording and punctuation of the first sentence of section 13 is ambiguous - it can be read as saying that only four of the Executive Committee are elected at the AGM, with voting being done by "the members, Head Judge and Immediate Past President."

There is no change to the intent of this section. The intent of the content being removed from the first sentence is captured in the new second paragraph.

Separating out the two areas that sentence covers - who comprises the Executive Committee, and how some of them are elected - removes this ambiguity.

Including the words "or appointed" in the new second paragraph aligns to the previous changes made to Section 10, where under some circumstances a member of the Executive can be appointed rather than elected.

"The Member levy of \$5 per club member aged 18 years and over and \$3 per club member aged 5 - 17 years, is calculated one month prior to each club's balance date and payable to the Association....."

# Reasoning:

Increased due to excessive costs for Senior and Junior nationals competitions, AGM and Judges workshops - which covers for all travel costs, accommodation and meal allowances.

If this passes - the Judges levies will require an amendment and increase needs to be included. Currently it is \$1 for seniors and .50c for juniors. So want to raise it to \$2 seniors and \$1 juniors

#### Amend Rule 1.4 (e)

Increase ticket levy charge from \$5.50 to \$12.00 for each Saturday and Sunday ticket sold, including door sales and spectator tickets.

**Replace** '\$5.50' with '\$12.00' and 'excluding' with 'including' and 'obliged' with 'required' **Add** '\$5 per spectator ticket'

#### To read:

"The host club of a National Championships is required to charge a levy of \$12.00 for each Saturday ticket sold and \$12.00 for each Sunday Ticket sold (including public door sales), \$5 per spectator ticket payable to the Association and forward such monies owing to the Association, no later than the one month after the championship".

Note: All monies due to the Association shall incur a ten percent penalty (10%) if not paid by the due date.

#### Reasoning:

As the numbers of our Nationals over the years have dropped, the cost of running the Nationals has increased for the NZARRA. The increase in costs is not just limited to flights, accommodation, and fuel. By increasing the levy cost and including the door sales the hope is to recover some of the cost increases. Below are examples of previous National profit and losses.

#### Reasoning:

As you must have seen, there has been a big drop in both competitor and spectator numbers at both Rock'n'Roll Nationals. The biggest drop being in our junior ranks with an 80% drop since 2019. (See numbers below).

We must ask the question if it is time to join the nationals and create a new, New Zealand Rock'n'roll Championship consisting of all our current sections over a weekend. We believe that time is here and now.

The reasons for combining our nationals are simply financial. As you can see in the charts below, a substantial drop in competitor and spectator's numbers has resulted in major financial losses to the NZARRA. These constant loses cannot be sustained and will result in the Association not being able to run both Junior and Senior New Zealand Rock'n'roll National competitions.

By combining nationals, the association would be able to save money by lowering expenses for accommodation, flights, travel, Exec meetings and meals twice a year to only once a year. However, the costs for some things will stay the same e.g. medals and certificates.

This event would be a full format from morning to night and if needed the competition could start on Friday night. The program will take some arranging however with numbers the way they are it would not be a lot different to what we saw in the high number days of the 90s. But an exciting weekend would be experienced by all. One of the benefits would be for juniors to watch the adults compete and like some of us, dream and inspire them to be just like that when they get older, and to keep them interested in competitive rocknroll.

# **Amend Rule 6.3 Points System**

In the first sentence, include the finals as being judged by points rather than placings.

#### To read:

"The heats, quarter-finals, semi-finals and finals are all judged on a points system..."

#### Reasoning:

When judging a final a judge may find it impossible to separate two sets of competitors, but under the existing rule they are compelled to pick one as 1st and one as 2nd. If a judge genuinely believes the competitors are equal and can't separate them, the points system allows both to be given the same marks.

If the argument is that there would be too many dance-offs if two couples/triples etc can't be separated across the entire judging panel, then they are clearly very close. However, based on the minimal number of dance-offs we currently have (including from heats, semis etc which are judged using the points system), this argument may not be as a big concern as thought, and wouldn't the points system be a fairer way to assess the competitors, rather than asking a Judge to actually change what they feel at the time.

From a competitor's perspective 4th place makes a massive difference to the placings. If the finals were accessed using the points system points it could be only that there were only 2 or 3 points difference between 1st and 4<sup>th</sup>, giving competitors a fairer reflection of how close the competition actually was.

Getting a 4th tells the competitors nothing, whereas the points system is more transparent. Under the points system if the competitors (from 1st to 4th) have been given 10, 9.5, 9.5 and 9, this indicates to those who placed 4<sup>th</sup> how close the competition was. By the same token if the competitors (from 1st to 4th) were marked 10, 9.5, 9 and 5.5, it shows the 4<sup>th</sup> placed couple were comfortably fourth which is more useful and meaningful for the dancers.

If need be, mark the finals by overall points rather than timing, harmony, and variety, with each judge simply marking each couple overall out of 10. This would follow the 1st to 4th system but put a numerical score out of 10 rather than a placing.

#### If this remit passes we would need to consider the below:

The removal of 6.4 (b) "Points are not awarded, each Judge places the competitors from first to last place. Thus the placings are determined by the Scrutineers and if tied a dance off would result."

Per Point 6 (see below), potentially changing the wording of 6.4 (c) "The three categories (Timing, Harmony and Variety) are judged together and not separately as in the heats, quarter and semi-finals."

Per Point 6 (see below), potentially changing the wording of 6.4 (a) "The finals are judged by 7 Judges."

If this Remit is adopted it needs to be determined whether 7 Judges would still be required in a final or 6 as per the heats etc.

The intention of rule 6.3.2 (b) is that in a Restricted final, if a couple receives two or more 'X's they will be placed last for that song. The rule currently gives scrutineers clear guidance on how to manage that couple, but doesn't take into account how to handle the marks awarded by other judges (who are unaware of the two 'X's).

This new rule makes it clear that during scrutineering the marks awarded by non-Xing judges should be amended to reflect that the couple is last for each judge, to ensure that the placings given to other competitors are not influenced by this couple.

# Item 6 - Kapi Mana

#### 11.1 NATIONALS CHECK LIST

(b) The dance floor shall be approximately 17m x 17m, with a clear perimeter around the entire floor excluding the seating area. The floor should be square rather than rectangle.

Amending 11.1(b) to allow more flexibility in the floor size. Enacting this provision to be done in consultation with the NZARNRA Executive.

#### Reasoning:

- Many potential National Championship venues feature a single basketball court with a standard sized zone around the perimeter. These venues measure approximately 22 metres wide by 38 metres long, leaving very little room to place tables, seating, and/or a stage between the 17m x 17m dance floor and the walls.
- The 17m x 17m dance floor requirement was added when up to 6 couples were allowed on the floor in heats. The maximum number of couples now allowed on the floor in any section is five.
- If adopted the proposed change may only apply to the Junior Nationals as the participants are generally smaller that Senior competitors and therefore require less dance floor space.
- If adopted the proposed change may allow a wider range of clubs to host National events.

Kapi Mana fully appreciates the NZARRA wants to have a recording of the event, but in light of the rapid changes in technology (mobile phones/tablets) and the means by which it can be filmed and distributed, consideration needs to be given as to how this can be done in the future.

This has been made more urgent by:

- Rotorockers filming their last event (2024 Senior Nationals).
- The rapid decline in the number of DVD/USB sold
